## GENERAL PRICE LIST

These prices are effective, **August 30, 2015** but are subject to change without notice.

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. *However, any funeral arrangements you select will include a charge for our basic services and overhead.* If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

### PROFESSIONAL SERVICES:

**Basic Services of the Funeral Director and Staff:** Our services include, but are not limited to, personnel on duty 24 hours a day to respond to your initial request for service, care and sheltering of the remains, preparation and filing of the death certificate and permits as necessary, consultation with the family, and coordination of service plans with the cemetery, crematory and others responsible for the final disposition of the deceased. This fee also includes a proportionate share of our basic overhead costs such as facility maintenance, administration, insurance, equipment and inventory costs and governmental compliance. This fee for our basic **services and overhead** will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

### PREPARATION:

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

**Equipment and Staff Services for Graveside Service** (Our services include accompaniment of remains to cemetery and supervision of graveside service.) Monday thru Friday only. **\$450.00**

**Equipment and Staff Services for Church Service** (Our services include accompaniment of remains to the church and supervision of the service.) Monday thru Friday only. **\$650.00**

**Facilities and Staff for Identification Viewing.** Monday - Friday, 9:00 am to 4:00 pm for a 5 minute period for two (2) people. **\$25.00**

**Facilities and Staff for Visitation.** Monday - Friday, 8:30 am to 5:00 pm for a two (2) hour period. **\$350.00**

**TRANSPORTATION:**

**Transfer of deceased from place of death, autopsy or tissue procurement facility to funeral home** (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties) additional mileage will be charged at \$2.25 per mile. **\$250.00**

**Use of Hearse** (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties) additional mileage will be charged at \$2.25 per mile. **\$350.00**

**Use of van in lieu of hearse to cemetery** (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties) additional mileage will be charged at \$2.25 per mile. **\$250.00**

**Use of Utility Vehicle for filing paperwork** (within 25 mile radius)  
Additional mileage will be charged at \$2.25 per mile **\$150.00**

**Transportation of remains from funeral home to place of autopsy or tissue procurement** (within 25 mile radius) additional mileage will be charged at \$2.25 per mile **\$250.00**

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME:**

Our services include basic services of the funeral director and staff, and transportation to local cemetery using a van in lieu of hearse. **Graveside service, viewing, dressing, casketing and cosmetics, additional transportation or cemetery fees, etc. are not included.** **\$595.00**

**DIRECT CREMATION: (\$595.00 to \$2,390.00)**

Our charge for a direct cremation (without viewing, rites or ceremony at the funeral home) include basic services of the funeral director and staff, a proportionate share of overhead costs, removal of remains (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties), refrigeration prior to cremation and obtaining necessary authorizations and consents. If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is unfinished fiberboard and can accommodate remains that weigh up to 325 pounds. We also include the crematory fee for remains up to 325 pounds. The cremated remains will be returned in a temporary container.

**IMMEDIATE BURIAL: (\$995.00 to \$2,790.00)**

Our charge for an immediate burial (without viewing, rites or ceremony at the funeral home, gravesite or elsewhere) includes basic services of the funeral director and staff, a proportionate share of overhead costs, removal of remains from place of death (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties), dressing or shrouding and transportation to local cemetery (within service area of Bell, Bexar, Blanco, Burnet, Caldwell, Comal, Guadalupe, Hays, Travis and Williamson Counties) using a van in lieu of a hearse and filing paperwork. Refrigeration is included prior to the burial.
